



- We introduce a new service for small and mediumsized enterprises: business opportunities – a list of up-to-date grant proposals and opportunities for entrepreneurs to give a new impulse to the development and expansion of business.
- We provide a service "legal address", specifically: office, information and consulting services, services on using office machinery, premises and equipment, postal and communications services, as well as place of business address.
- We attend international projects supporting entrepreneurship, searching for business partners, investors, donors etc.
- There is a successful implementation of the project "Stand for Ukrainian Business" within the Program "EU4Business: SME competitiveness and internationalization" funded jointly by the European Union and the German Government through the German Government Company Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH.

- We conduct annually the competition "The Best Exporter of the Year" among small, medium and large-sized enterprises of Kyiv City.
- We provide information and analytical notes on manufacturers of products (services) in Ukraine.
- We prepare topical collections of documents, provide consultations in running business, investment and innovative proposals.
- We perform search for national and foreign partners using our communications channels with regional and foreign chambers of commerce and industry, embassies, trade and economic missions, specifically engaging the members of the International Trade Club in Ukraine.
- Since June 2022 we have been arranging business lunches for business owners and top management to meet with known politicians, economists, entrepreneurs and industrialists. During such lunches, participants could get an exclusive analysis of Ukraine's economy development under conditions of martial law and an algorithm of successful steps to keep and scale up business.







## **NEW SERVICES DURING THE WAR**

The Kyiv Chamber was the first among regional chambers of commerce and industry of Ukraine which joined the process of recording and photo fixating the results of external inspection of the property destructed/damaged as a result of military activities. The purpose is to define the evidence and establish the losses suffered by entrepreneurs due to the armed




